**Consolidation and Benefit Redetermination Hearing for  
Otter Tail County Ditch System Number 15 and Otter Tail County Ditch System Number 28**

**NOTICE IS HEREBY GIVEN TO THE PROPOSED BENEFITED PROPERTY OWNERS OF COUNTY DITCH SYSTEM NUMBER 15 AND COUNTY DITCH SYSTEM NUMBER 28** that the County Drainage Authority will hold a public hearing at 7:00 p.m. on Monday, October 20, 2014, in the meeting room at the Government Services Center (located at 515 Fir Ave W), Fergus Falls, Minnesota for the purpose of discussing and considering the preliminary Ditch Viewers' Report of Benefits.

The County Board of Commissioners, Ditch Authority for County Ditch System No. 28, having held a public information meeting on County Ditch No. 28 on the 24th day of June, 2013, having received a report from Kevin Fellbaum, County Ditch Inspector, having reviewed the files and being fully advised in the premises did on the 9th day of July, 2013 order the redetermination of benefits for County Ditch System No. 28. During the County Ditch System No. 28 redetermination process it became apparent that County Ditch System No. 15 and County Ditch System No. 28 share a common watershed. The County Board of Commissioners, Ditch Authority for County Ditch System No. 15 did on the 8th day of April, 2014 order the redetermination of benefits for County Ditch System No. 15 and consideration of the possible consolidation of County Ditch System No. 15 and County Ditch System No. 28.

County Ditch System No. 15 and County Ditch System No. 28 run through and/or benefit properties in the watershed located in Sections 3 through 10 and Sections 15 through 18 of Amor Township, Section 5, Sections 7 through 10, and Sections 14 through 36 of Dead Lake Township, Sections 1 through 4, Sections 8 through 12 and Section 17 of Maine Township, Sections 30 and 31 of Rush Lake Township, and Sections 23 through 27 and Sections 34 through 36 of Star Lake Township.

The Ditch Viewers reviewed the Ditch Viewers' Report dated July 15, 2014 with the County Board of Commissioners on Tuesday, July 22, 2014 and filed Ditch Viewers' Report and detailed data file with the County Auditor's office on Tuesday, July 29, 2014. The County Auditor's Property Owner's Report was presented to the County Board of Commissioners on Tuesday, September 9, 2014. The Ditch Viewers' Report along with the County Auditor's Property Owners' Report provides the information required by Minnesota Statute 103E.321 and 103E.323. The report states that the total re-determined benefits are \$17,982,044.57, including benefits assigned to county and township roads in the amount of \$23,085.26. The acres within the watershed/drainage area are approximately 17,517.69.

Property owners within the watershed area, concerned citizens and other interested parties with questions and comments are encouraged to attend the above referenced public hearing. The Ditch Viewers will be available at the public hearing to address your questions and concerns.
