**ORDER FOR REDETERMINATION  
OF BENEFITS**

The Otter Tail County Board of Commissioners, having ordered a redetermination of benefits on Ditch No. 16, and having received the Ditch Viewers' Report which was presented and considered at a public hearing held on April 2, 2009, in the auditorium at the Battle Lake High School, Battle Lake, Minnesota; the Board then having asked the viewers to reconsider some of the issues raised by the public; the viewers then submitted amendments to the Ditch Viewers' Report at a continued public hearing held at a regularly scheduled County Board meeting on May 5, 2009; and the County Board having reviewed all the files and proceedings herein, and being fully advised in the premises, makes the following Findings and Order:

FINDINGS

1. That on January 15, 2008, the Otter Tail County Board of Commissioners, drainage authority for Ditch No. 16, issued an order directing a redetermination of benefits for Ditch No. 16 and appointed Eldor Kugler, Howard Goese and Richard Bergquist as Ditch Viewers for the redetermination of benefits.
2. The Auditor mailed out the Property Owners' Report as required by Minnesota Statute § 103E.323.
3. The Ditch Viewers submitted their report to the drainage authority, and a public hearing was held on April 2, 2009, to consider the viewers' report, at which time it appeared some corrections to the report may be appropriate. The drainage authority directed the viewers to

re-examine some of the parcels contained in the report, and the public hearing was continued to May 5, 2009.

4. The viewers submitted amendments affecting nine parcels as reflected on the abstract from the Amended Viewers' Report, a copy of which is marked Exhibit A, and attached hereto.


5. The Amended Viewers' Report accurately reflects the benefits to land served by Ditch No. 16 in conformity with the provisions of Minnesota Statutes Chapter 103E.

6. That the full copy of the Amended Viewers' Report is on file with the Office of the Otter Tail County Auditor, and available for viewing on the Otter Tail County web site, [www.co.ottertail.mn.us](http://www.co.ottertail.mn.us)


ORDER
